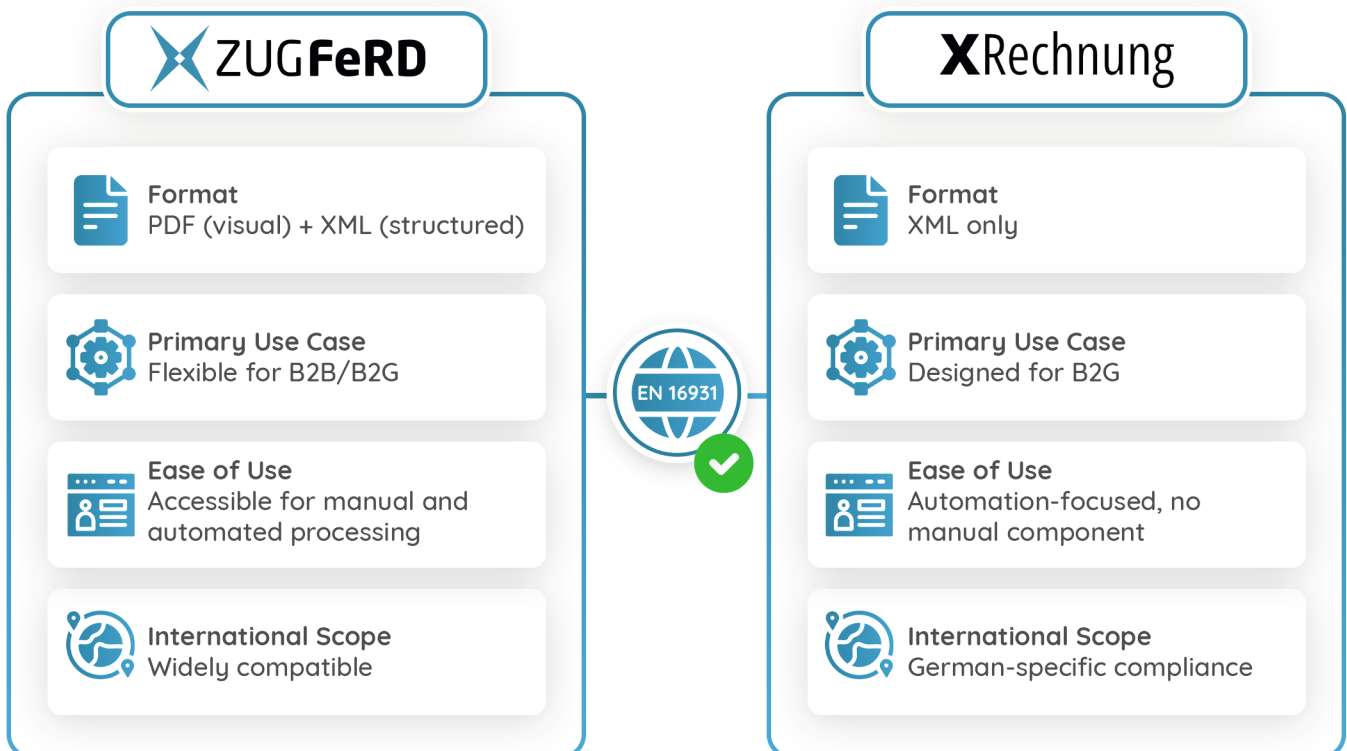

Differences between major e-invoicing format standards

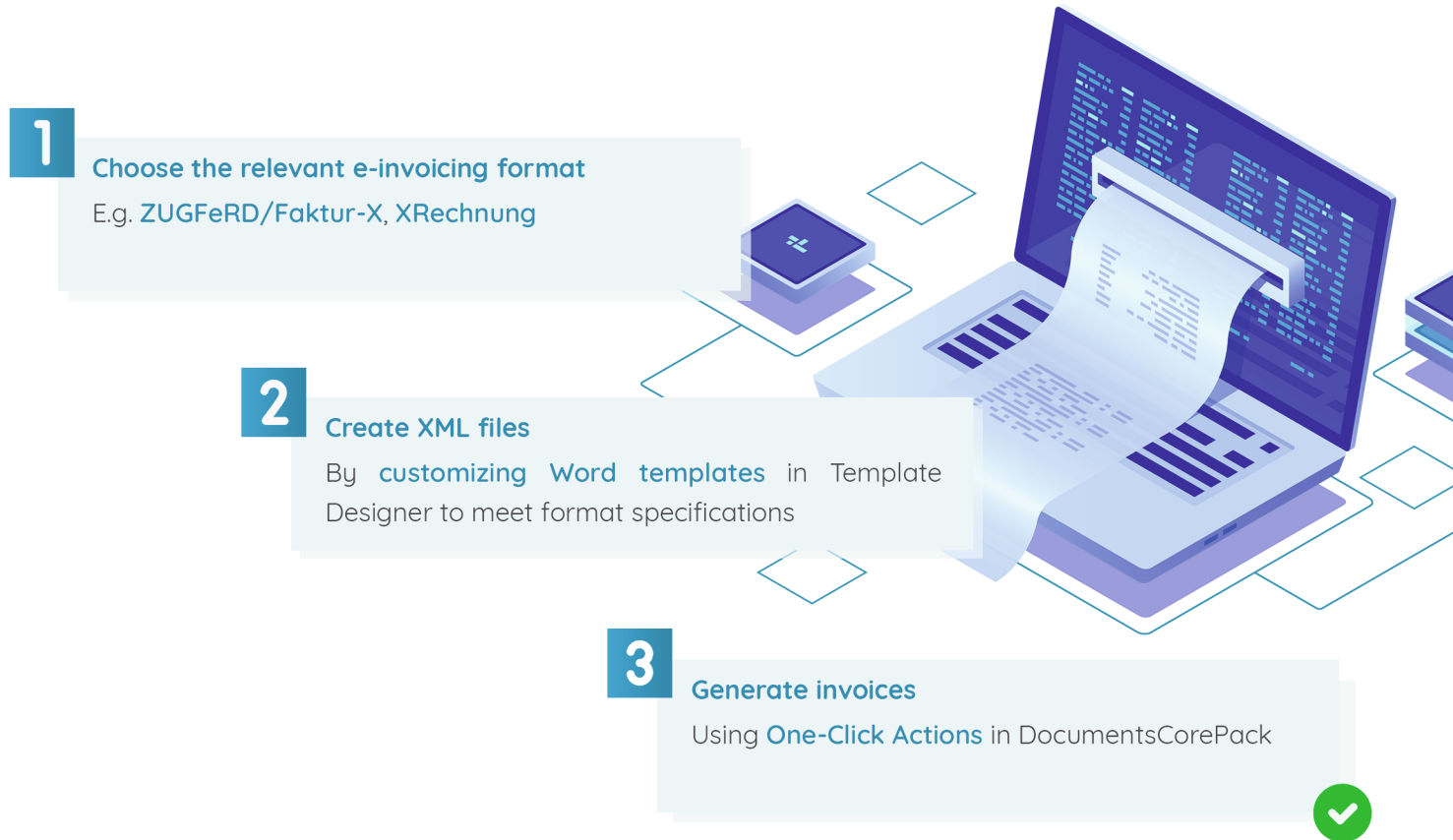
There are many e-invoice format standards, each tailored to different needs. In Germany, ZUGFeRD (Zentraler User Guide des Forums elektronische Rechnung Deutschland) and XRechnung are widely used to meet legal requirements and align with the European standard EN 16931. ZUGFeRD/Faktur-X combines a human-readable PDF/A-3 with embedded XML data, making it ideal for B2B scenarios where both visual and machine-readable invoices are needed. XRechnung, a purely XML-based format, is designed for electronic invoicing with public authorities, prioritizing automation and strict compliance. While ZUGFeRD/Faktur-X offers flexibility, XRechnung specializes in meeting public sector requirements.

EU-compliant e-invoicing formats are built around XML (Extensible Markup Language), which is used to structure the data in a specific format according to predefined rules. These schemas outline the required structure, elements, and data types, ensuring that the invoices can be processed seamlessly by both sending and receiving systems.
